SEACHOICE warrants its marine filters to be free from defects in material and workmanship. SEACHOICE marine filters are manufactured to high quality standards and guaranteed to meet all requirements of engine and equipment manufacturers.

This LIMITED LIFETIME WARRANTY extends from the date of installation of the SEACHOICE product for the hours published in the owner's vehicle manual as the recommended service interval for filter replacements ("Warranty Period"). SEACHOICE will replace any of its filters that, under normal conditions of use, if proven to be defective in material or workmanship and is within the Warranty Period. If SEACHOICE further determines, in its sole discretion that the alleged defective filter caused engine damage during the Warranty Period, SEACHOICE will also repair or replace any damaged engine parts.

THIS LIMITED LIFETIME WARRANTY DOES NOT COVER damages caused by incorrect application, improper installation and damages or failure caused by rust or corrosion. SEACHOICE is not responsible for downtime, loss of income, living expenses, or other identical consequential damages. **THIS LIMITED LIFETIME WARRANTY IS VOID** under the following circumstances:

- *Use of motor oil other than the viscosity and type as recommended in the owner's vehicle manual.*
- *Damage or failure caused by misuse, negligence, modification, accidents, or abuse.*
- *Damage or failure caused by unauthorized service or use of unauthorized parts.*

SEACHOICE reserves the right to make changes in design or improvements to its filters without creating or assuming any obligation to install or implement the same on its filters previously sold. SEACHOICE AND ITS AFFILIATES AND SUBSIDIARIES WILL NOT BE LIABLE FOR ANY CONSEQUENTIAL, INCIDENTAL, SPECIAL OR EXEMPLARY DAMAGES OF ANY KIND. ALSO, TO THE EXTENT PERMITTED BY LAW, THIS LIMITED LIFETIME WARRANTY SETS OUT YOUR EXCLUSIVE REMEDIES WITH RESPECT TO THE FILTERS. NO ATTEMPT TO ALTER, MODIFY OR AMEND THIS WARRANTY SHALL BE EFFECTIVE UNLESS AUTHORIZED IN WRITING BY AN AUTHORIZED REPRESENTATIVE OF SEACHOICE.

To file a claim under this limited lifetime warranty, you must submit a warranty claim to the SEACHOICE Customer Service Department within 30 (thirty) days after discovery of the damage or failure. You must also allow the SEACHOICE Customer Service or its appointed representative to examine the filter, and, if required, the engine or equipment, to determine the extent of damage and whether it was caused by a defective SEACHOICE product. You should retain the copy of your service records and installation record and receipt as a proof of the date of purchase. The filter must be returned to the SEACHOICE Customer Service, unaltered, for examination, along with the proof of purchase, service, and installation records.
